DIRECT LEGAL SERVICES: ILAP provides a continuum of services based on client needs and goals. Full Representation is reserved for complex cases that have dire consequences and are unlikely to be successful without an attorney. The Immigration Forms program offers consultations, brief interventions and application assistance to individuals navigating the immigration system. In 2018, ILAP represented 371 Full Representation clients and served 1,139 individuals in the Immigration Forms program. For the third year in a row, 100% of cases that reached a final decision were successful. Additionally, 178 pro bono attorneys donated 3,724 hours of their time valued at \$937,242.

EDUCATION & OUTREACH: To maximize our reach and support individuals that we do not have the capacity to represent, ILAP provides accurate, accessible and timely information on complex legal issues to immigrant communities and service providers across the state. Available in several languages, materials and presentations aim to counteract incomplete or inaccurate information and prevent future complications that may negatively affect legal status or lead to deportation. These activities have become particularly important over the last two years, as many policies changed swiftly and significantly. In 2018, we hosted 60 educational outreach events for 1,794 individuals across the state.

SYSTEMIC ADVOCACY: ILAP collaborates with partner organizations and immigrant-led groups on systemic advocacy efforts to improve laws and policies that affect immigrants in Maine and prevent those that would negatively impact immigrant communities. In 2018, ILAP served as a source of accurate information for the media on 30 occasions. Key advocacy activities included testifying before the state legislature in support of a bill establishing the crimes of criminal forced labor and aggravated criminal forced labor (which passed), collecting public comments on proposed changes to the federal "public charge" rule and regularly briefing Maine's Congressional delegation.
