DIRECT LEGAL SERVICES: ILAP offers a continuum of direct legal services based on client needs and goals, including full representation, brief intervention, consultations, and application assistance. In 2020, we provided full representation to 388 people and limited representation to 1,257 people. We maintained a 96% approval rate for full representation cases that received a final decision. In addition, 175+ pro bono attorneys donated nearly 4,000 hours of their time at a value of more than \$1 million.

COMMUNITY EDUCATION: ILAP provides accurate and accessible information on complex legal issues in multiple languages for immigrant community members, groups, and service providers across the state. In 2020, we hosted 62 outreach events (in-person or remotely) attended by 1,396 individuals, including a weekly asylum workshop series. We also expanded the client education and self-help tools available on our website, which had 28,000 unique page views by more than 12,500 users.

SYSTEMIC ADVOCACY: ILAP collaborates with immigrant-led groups, partners in Maine's immigrant justice movement, and regional and national organizations to safeguard and promote legal protections for the state's immigrant communities. In 2020, we served as a source of accurate information for the media on 32 occasions, submitted seven public statements or testimonies, joined more than 25 sign-on letters on a range of issues, and shared timely policy and action updates with thousands of supporters.
